

## HUNTING RULES AND REGULATIONS AT Currituck Banks

- All hunters must have a valid 2018-2019 North Carolina Hunting License and a valid 2018-2019 Coastal Reserve Hunting permit. Valid permits must be carried on person while hunting.
- Hunters are responsible for knowing and abiding by local, State and Federal hunting regulations and knowing Reserve boundaries.
- Hunters must access Reserve from the beach. Access for hunting via the visitor parking lot and boardwalk is PROHIBITED.
- Hunting is allowed from 150 yards north of the "Maritime Forest Trail" to the northern boundary. Hunting is not allowed south of the "Maritime Forest Trail" or east of the underground power line (i.e. Cable Trail) (see map).
- NO baiting and NO hunting with rifles or dogs is allowed.
- You may NOT construct or use permanent blinds, tree stands, platforms or ladders. Tree stands should be removed from the Reserve after each day's hunt. No personal property may remain on the Reserve overnight.
- NO ATV's or dirt bikes allowed in the Reserve. NO motorized vehicles allowed off beach strand.
- Hog hunting is only allowed during the dates of this permit.
- All hunters are REQUIRED to report any successful taking of wildlife within the Reserve by calling 252-261-8891. This is in addition to NC Wildlife Resources Commission reporting requirements.

**For this permit to be valid, you must first submit a registration form, available through the Reserve's website or at the office. You will then receive the "Hunter Registration Number" for your permit. Carry this permit with you at all times while hunting.**
